FLY is continuing to advocate for improved conditions in juvenile halls, camps, ranches, & SYTFs across the state. To learn more about the Board of State and Community Corrections (BSCC) and the Title 15 and 24 Regulations revisions process, check out their <u>webpage</u>.

In February, a workgroup convened to discuss changes to food and nutrition in locked facilities. FLY showed up to advocate for changes and we had some great initial victories from the workgroup, including:

- Youth cannot be forced to eat meals in silence
- Youth must be offered a snack between each meal and after dinner
- Discipline policies cannot include denying youth access to food, including snacks

At the end of April, Nallely Navarro, former FLY Youth Policy Fellow and current Youth Voice Coach, will serve as a Medical & Mental Health Workgroup member. She is preparing to advocate on behalf of our youths' priorities, while supporting youth to learn about this process and coaching them to make public comments.

SMC: LOCAL SPOTLIGHT!

The SMC Network is a new FLY initiative to connect FLY alumni with one another! In addition to building community with one another, the network participants are interested in engaging in local advocacy. Led by Rose Lavalley, FLY Youth Voice Coach, they have built relationships with local groups such as the Coalition for a Safer SMC and the Juvenile Justice Delinquency Prevention Commission.

A recent highlight for the SMC Network was two youth making their first ever public comment at the SMC Board of Supervisors meeting. They advocated for more intentional sheriff oversight in the county.

AC: LOCAL SPOTLIGHT!

The Alameda County Youth Advisory Council has been hard at work over the past few months:

- In December, the YAC spread holiday cheer by creating stockings for youth in the foster care system who were on probation. They also gifted calendar pocket books and personalized bookmarks to youth at Juvenile Hall & Camp Sweeney. One council member recalled having a calendar while incarcerated and spoke about how helpful it was to keep track of court dates, birthdays, and other important information.
- In January, the YAC traveled to Sacramento to attend an Assembly Public Safety Committee Hearing and toured the capitol.
- Finally, in February, the YAC collaborated with the Public Defender's Office to lead a 3-part workshop series on Voting for youth in juvenile hall. After completing a facilitation training, five council members led workshops focused on voting rights, the importance of the board of supervisors, and an overview of the primary ballot.
