

LEGISLATIVE PRIORITIES

ECONOMIC IMPACT AB 1186

AB 1186 (Bonta), the REPAIR Act (Realizing Equity while Promoting Accountability and Impactful Relief), is co-sponsored by FLY. The bill will provide crime survivors with more equitable, timely, and stable state-funded compensation while allowing youth to make amends through non-monetary and youth-appropriate alternatives. SB 448 SB 448 (Becker), the Equity for Youth in Detention Act, co-sponsored by FLY, will require that youth detained in a county outside of their county of residence must receive the same consideration for the least restrictive alternatives to detention that are given to youth who are detained in their county of residence. Fact Sheet

AB 702 AB 702 (Jackson), the Promoting Youth Success and Empowerment Act (PROMYSE Act), is co-sponsored by FLY. The bill would help California fully realize the Juvenile Justice Crime Prevention Act's vision of providing collaborative, restorative, community-based services for young people and ensuring equitable representation and decision-making within county oversight bodies. AB 1643 AB 1643 (Bauer-Kahan) will raise the informal supervision threshold from \$1,000 to \$5,000, allowing more youth to access informal supervision and take advantage of the program's benefits, allowing the harm caused by lowrisk youth to be addressed outside of the formal juvenile justice system. LEGISLATIVE PRIORITIES

AB 505 AB 505 (Ting) would ensure that the Office of Youth and Community Restoration (OYCR), the state's first and only health-focused youth justice office, has the tools it needs to protect youth from abuse and continue California's youth justice system transformation that began in 2020. Fact Sheet

AB 912

AB 912 (Jones-Sawyer) reinvests \$235 million of cost savings from prison closures into programs that reduce violence, provide diversion opportunities, and deliver critical community supports, including mental health, education, and vocational services.

AB 60 AB 60 (Bryan) will require that survivors and victims of harm receive notice of the availability of community-based Restorative Justice programs and processes in their community.

AB 958 AB 958 (Santiago) establishes personal visits for incarcerated people as a limited civil right rather than a privilege and ensures that revoking visitation rights are limited to special circumstances.

SB 274 SB 274 (Skinner) seeks to improve student success by creating a more supportive academic environment and encouraging schools to consider alternatives to suspensions and expulsions by eliminating the "willful defiance" suspensions and expulsions.

LEGISLATIVE PRIORITIES

SB **50** AB 93

SB 50 (Bradford) will limit law enforcement's ability to use minor, non-safetyrelated traffic infractions to conduct racially biased pretextual stops. Fact Sheet

AB 93 (Bryan) will prohibit police officers from pursuing searches that are based solely on a person's purported consent rather than evidence of illegal activity. Fact Sheet

AB 762 AB 762 (Wicks) would reauthorize the CalVIP Grant Program, which provides the structure and framework for an evidence-based focus on supporting community-based violence intervention and prevention services in communities most impacted by cycles of violence across California. Fact Sheet

AB 28 AB 28 (Gabriel) would sustain critical but temporary investments California has made in violence intervention and prevention programs by placing a surtax on the firearm industry to fund programs that effectively remediate the devastating human toll their products take on families and communities across the state.
