### Bills Signed into Law

One of FLY's co-sponsored bills, AB 1186, and five other bills we supported, were signed into law this year! Assembly Bill 1186 makes important reforms to California's youth restitution system by ending youth restitution fines, releasing uncollectable debt that is over 10 years old, eliminating wage and trust garnishment, and right-sizing financial orders.



## 2024 YOUTH POLICY FELLOWS

FLY had an amazing cohort of Youth Policy Fellows in 2024: Jose, Aydeth, Erial, Luca, & Maleek! The fellows supported FLY to identify our legislative priorities by carefully analyzing 21 bills. Of these bills FLY co-sponsored 2, supported 13, and opposed 6. The fellows then spent the year tirelessly advocating for our priorities in the state legislature with 7 trips to Sacramento and over 50 legislative visits with Senators and Assemblymembers.





"I didn't realize how much I would learn this year, the experience was profound. We pulled back the curtain and learned about how the government really works. It's important for youth to be close to people in power because it shows we belong in those spaces and we can affect change. Also, you realize the people in Sacramento aren't so out of reach. People like us can run for city council or the State Legislature. After this fellowship, I'll always be involved in some type of organizing work because I want to leave the world better than I found it."



## FLY'S BSCC ADVOCACY UPDATE Run



#### >>>>> Youth Policy Fellows Mobilizing Youth Advocates!

In addition to their legislative advocacy, FLY's 2024 Youth Policy Fellows picked up where last year's Fellows left off and continued FLY's Board of State and Community Corrections advocacy. They hosted a series of three trainings to teach youth about the BSCC and how to advocate for improved conditions in youth locked facilities through public comments. The Fellows supported five youth to make a public comment for the first time on topics including addressing the lack of hygiene and menstrual products, ending the use of chemical spray against youth, and providing high-quality meals with proper nutrition.

#### >>>> What's Next?

We are nearing the end of a 3-year process of revising the minimum standards probation must follow when operating a juvenile hall, camp, ranch, or SYTF. FLY youth have been involved in every step to demand accountability to their lived experiences and push for real solutions that change the dangerous and inhumane conditions inside locked facilities. In the coming months, the Executive Steering Committee will reconvene to finalize the revisions. FLY youth and staff will attend to make public comment and continue holding them accountable.






## Y.O.U.T.H Advocacy Day Pro

#### **In the Community:**

 Alameda County Youth Advisory Council members are building on their efforts from the March primaries by hosting another series of voter education workshops in Alameda County Juvenile Hall in October. They are working to register and pre-register youth in the hall and spread the word that youth over 18 years old have the right to vote even if they are currently incarcerated!
