### WAYS TO GIVE:

#### BEQUESTS

A bequest is a gift made through your will or living trust. You can specify an amount, a percentage of your estate, or specific assets. Bequests are simple to arrange and can be changed at any time.

#### BENEFICIARY DESIGNATIONS

You can name FLY as a beneficiary of your retirement accounts, life insurance policies, or financial accounts. This option is flexible and can provide significant tax advantages.

#### CHARITABLE REMAINDER TRUSTS

Allows you to receive income for life or a term of years, with the remainder going to FLY. This type of trust can provide you with a steady income stream and potential tax benefits.

#### CHARITABLE LEAD TRUSTS

Provides income to FLY for a term of years, with the remainder going to your heirs. This can significantly reduce gift and estate taxes.

#### GIFTS OF REAL ESTATE OR OTHER ASSETS

You can donate real estate, stocks, bonds, or other assets to FLY. These gifts can be arranged to provide you with tax benefits and support our mission.
